

KUDOS - INCENTIVES FROM LIME TERMS & CONDITIONS

- Bookings made the following day will not be eligible for the previous day's win. I.e. you can't enter on Thursday and book nothing until Friday, you have to enter between 00:00 23:59 and book in that same period or enter & book all over again the following/each day.

- GDS users will need to submit their eligible unticketed PNRs created in June 2018 by emailing them to marketing@lime-management.com once registered
