An eligible participant and his/her travelling companion is a person aged 18 years or over who is resident in the United Kingdom and the employee must be employed by an IATA agent in the United Kingdom during the incentive and at the point in which the prizes are awarded. Employees of British Airways ("BA"), its subcontractors, or of a BA company cannot participate in this prize draw. BA reserves the right to verify the eligibility of Eligible Participants. By taking part in this prize draw, Eligible Participants confirm (i) that they accept the terms and conditions set out below and (ii) agree to the processing and use by the Promoter, its agents or contractors of the personal data supplied to administer the prize draw.
2. To participate in this prize draw, Eligible Participants must: Book an Eligible Flight and make an Eligible Entry.
3. An Eligible Flight is one which comprises of travel on British Airways services to/from Inverness (INV) – London Heathrow (LHR).

5. Bookings need to be ticketed on BA 125 paper.
6. There is no limit to the number of entries eligible participants can submit to participate in this prize draw.
7. Incorrect or late entries will not be accepted. BA accepts no responsibility for damage or loss resulting from misdirected or incomplete entries arising from computer malfunctions, viruses, bugs or other such causes. ### Prize:
